Proceedings of the Manawa Common Council meeting held Monday, February 18, 2019. Called to order at 6:00 PM by Mayor Smith at the Manawa Municipal Building pursuant to open meeting regulations, Pledge of Allegiance and roll call. Aldermen present on roll call: Brown, Eck, Brost, Radtke, Miller, Frazier. City Employees: B. Gorman, J. Gorman, M. Hass, L. Hass. Audience: Holly Neumann.

Moved Frazier/Miller to approve agenda of February 18, 2019. Carried.

Moved Brown/Miller to approve of the common council meeting minutes of January 21, 2019. Carried.

Moved Miller/Eck to approve of the Bills of Allowance \$98,524.69. Carried.

Finance: On Call: Moved Eck/Frazier that on call time shouldn't be paid when the employee is not at work. Carried.

<u>Time Clock:</u> Moved Eck/Radtke to give permission to Jim Gorman to investigate for a time punch clock for city employees. Carried.

<u>Snow Plowing:</u> Moved Eck/Frazier to pay Frank Jaeger his leaving wage for his time snow plowing. Carried.

<u>Assistant to the DPW position:</u> Eck informed everyone that they have been doing interviews for the position and there are some good candidates for the position. The council will be doing more interviews on February 25th.

<u>103 S. Bridge Street Property:</u> Moved Frazier/Eck to make final offer for property at 103 S. Bridge Street. Carried.

Protection: <u>Municipal Court:</u> Brown noted that the municipal court is self-sustained so we don't owe any money.

<u>Fire:</u> Miller stated that it was good to see the Fire Department at the Snodeo. Eck stated that the department has been working on the municipal agreement and open records request. There are 2 new co assist coordinators for ambulance director to help out Andy who has been very busy.
