Moved Miller/Frazier to approve agenda of March 18, 2019. Carried.

Moved Miller/Radtke to approve of the common council meeting minutes of February 18, 2019. Carried.

Moved Eck/Radtke to approve of the Bills of Allowance \$252,237.00. Carried.

Audience: Corey Durrant presented information about shooting bow on his 3 acres property in the city. Council member Radtke mentioned to Corey to talk to the neighbors and see what they say and get a petition filled out to bring back to present to the council.
