Moved Eck/Brown to approve the agenda of January 17, 2022. Carried.

Moved Eck/Bonikowske to approve of the common council meeting minutes of December 20, 2022. Carried. Moved Buelow/Brown to approve of the Bills of Allowance \$729,280.06. Carried. **Finance:** Chair Eck said we met with Josh about Kolbe Lift Station in the TIFF.

**Mayor:** <u>Library Board:</u> Moved Eck/Buelow to appoint Jessica Rosenow to Library Board. Carried. Mayor Frazier recognized Police Chief Jim Gorman for 6 years of service.
