COMMON COUNCIL MEETING  
AUGUST 15, 2022 6:00**

Proceedings of the Manawa Common Council meeting held Monday, August 15, 2022. Called to order at 6:00 PM by Mayor Frazier pursuant to open meeting regulations, Pledge of Allegiance and roll call. Alderpersons present on roll call: Mary Eck, Aaron Timm, Ann Bonikowske, Seth Miller, Jim Roenz, Alice Brown and Mayor Mike Frazier. City Employees: Josh Smith, Jason Severson and Logan Hass. Audience: Holly Neumann.

Moved Roenz/Brown to approve the agenda of August 15, 2022. Carried.

Moved Bonikowske/Eck to approve of the council meeting minutes of July 18, 2022. Carried.

Moved Roenz/Timm to approve of the Bills of Allowance \$102,616.01. Carried.

**Protection:** Halloween Trick and Treat hours: Moved Roenz/Eck Halloween Trick & Treat time set for Saturday October 29<sup>th</sup> from 2pm to 4 pm. Carried. Fire board report Mayor Frazier said that EMT's hourly wage might increase and Eck said that internal audit is completed. Brown said municipal court is meeting on September 8<sup>th</sup>.

**Mayor:** Mayor Frazier thanked everyone for their help at Manawa Night Out.

**DPW:** Josh said trail cameras placed at well 5 and 6 with no trespassing signs because some of the manhole covers were stolen, working on filling sink holes, trimming trees back, Manawa Football team will be painting fire hydrants this Wednesday as a community service act, did not receive grant for Factory Street, there is a possible different avenue for grants that the city can go through, updating park bathrooms lighting, jetting mains, exercise water valves and flush hydrants. Roenz brought up about the condition of the court at the park. Josh said patching is just a band aid the best thing to do is put it in brand new. Roenz asked about Pickleball lines. Josh said we can put it in just don't know what the dimensions would be for it. Roenz said he will stop down at the park.

**Police:** Chief Severson said there were 65 calls in July, Manawa Night Out was a success, Police Facebook page is up and running, looking into Archive Social which automatically saves social media posts the cost would be \$3,588 annually, Officer Shannon and I will be doing some training and there will be an audit done on the evidence room.

**Fire:** Chief Josh Smith said working on getting the new tender truck ready, firefighter 1 class will be starting up next month, sent the UTV to the Meet the Fleet event in Weyauwega, responded to 9 calls in last month and 76 calls for the year.

**Library:** Board Rep Brown said Ellen has lots of good programs going on right now.

**Clerk:** Financial Report: General Fund balance: \$104,005.64; Government Pool: \$101,312.41.

Licenses: Moved Eck/Bonikowske to approve operator's licenses for Bradley Batten and Brianna Dement. Carried.
